

#### **Potential Health Effects**

#### Inhalation:

Causes irritation to the respiratory tract. Symptoms may include coughing, shortness of breath.

#### Ingestion:

Harmful if swallowed. May affect bone marrow and consequently white blood cell, red blood cell, and platelet counts.

#### **Skin Contact:**

Causes irritation, redness and pain. May also cause allergic skin eruptions. Sunlight may aggravate skin allergy.

#### **Eye Contact:**

Causes irritation, redness, and pain.

#### **Chronic Exposure:**

Chronic exposure can cause liver damage and goiter (an enlarged thyroid gland). May affect bone marrow which could cause damage to blood. Material is a possible human carcinogen.

#### **Aggravation of Pre-existing Conditions:**

Persons with preexisting skin disorders may be more susceptible to these substances.

### 4. First Aid Measures

#### Inhalation:

Remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical attention.

#### Ingestion:

Induce vomiting immediately as directed by medical personnel. Never give anything by mouth to an unconscious person. Get medical attention.

#### **Skin Contact:**

Immediately flush skin with plenty of soap and water. Remove contaminated clothing and shoes. Get medical attention. Wash clothing before reuse. Thoroughly clean shoes before reuse.

#### **Eye Contact:**

Immediately flush eyes with plenty of water for at least 15 minutes, lifting lower and upper eyelids occasionally. Get medical attention immediately.

### 5. Fire Fighting Measures

Fire:

As with most organic solids, fire is possible at elevated temperatures or by contact with an ignition source.

**Explosion:** 

Fine dust dispersed in air in sufficient concentrations, and in the presence of an ignition source is a potential dust explosion hazard.

Fire Extinguishing Media:

Water spray, dry chemical, alcohol foam, or carbon dioxide.

**Special Information:** 

In the event of a fire, wear full protective clothing and NIOSH-approved self-contained breathing apparatus with full facepiece operated in the pressure demand or other positive pressure mode.

### 6. Accidental Release Measures

Remove all sources of ignition. Ventilate area of leak or spill. Keep unnecessary and unprotected people away from area of spill. Wear appropriate personal protective equipment as specified in Section 8. Spills: Pick up and place in a suitable container for reclamation or disposal, using a method that does not generate dust. US Regulations (CERCLA) require reporting spills and releases to soil, water and air in excess of reportable quantities. ## 7. Handling and Storage

Keep in a tightly closed container, stored in a cool, dry, ventilated area. Protect against physical damage. Isolate from oxidizing materials. Wear special protective equipment (Sec. 8) for maintenance break-in or where exposures may exceed established exposure levels. Wash hands, face, forearms and neck when exiting restricted areas. Shower, dispose of outer clothing, change to clean garments at the end of the day. Avoid cross-contamination of street clothes. Wash hands before eating and do not eat, drink, or smoke in workplace. Containers of this material may be hazardous when empty since they retain product residues (dust, solids); observe all warnings and precautions listed for the product.

## 8. Exposure Controls/Personal Protection

**Airborne Exposure Limits:**

**Ventilation System:** 

A system of local and/or general exhaust is recommended to keep employee exposures as low as possible. Local exhaust ventilation is generally preferred because it can control the emissions of the contaminant at its source, preventing dispersion of it into the general work area. Please refer
